**ORDINANCE NO.2025-26 ROAD**

An ordinance levying taxes for all road purposes for HERALDS PRAIRIE Road  
District White County, Illinois, for the tax year 2025 , collectable in 2026.

BE IT ORDAINED by the Board of Trustees of HERALDS PRAIRIE Township,  
White County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of HERALDS PRAIRIE Road District  
on October 6, 2025 does hereby determine and declare that the sum of  
Eighty Four Thousand Two Hundred Dollars (\$84,200.00) are hereby levied  
upon all property subject to taxation within the Road District as that property is assessed and equalized,  
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by  
statute or voted by the people in accordance with the law, for such purposes as:
