**ORDINANCE No. 2025-26a Annual Heralds Prairie Township Levy**

An ordinance levying taxes for all town purposes for Heralds Prairie Township,  
White County, Illinois, for the tax year 2025 collectible in 2026.

BE IT ORDAINED by the Board of Trustees of Herald Prairie Township,  
White County, Illinois, as follows:

SECTION 1: That the sum of One Hundred Sixty Four Thousand Five Hundred Dollars  
(\$164,500.00) are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:

General use and purposes of the Township General Fund, Administration,  
Personnel and Contractual Services, Commodities,  
Other Expenses, Capital Outlay,  
Contingencies, General Assistance Fund, Liability Insurance, Payment to IMRF, Payment to Social Security.  
for the year 2025.
